# POLIMAL®

### Application

**Polimal® 122-2 WTP-2** is recommended for the production of polyester – glass laminates by hand lay-up and spray lay-up.

### Resin characteristics

**Polimal® 122-2 WTP-2** is constructional, accelerated, thixotropic, unsaturated polyester resin on the base of isophthalic acid, with colorful curing indicator. It is characterized by very good processing and mechanical parameters. It has high thermal and water resistance.

Mechanical parameters refer to not reinforced resin curing for 24 hours at room temperature and post curing for 2 hours at 80°C.

## **122-2 WTP-2**

### Storage conditions

**Polimal® 122-2 WTP-2** should be stored in close package in a dry, shady and cool places, adapted for storing flammable materials at temperatures not exceeding 25°C.

### Processing conditions

The resin should be mixed before use. Good curing required ambient temperature above  $18^{\circ}$ C and low air humidity. The best curing conditions are obtained using 2% MEKP as hardener. It is possible to adjust gel time by varying of amount of hardener, the best within in the range of 1 - 2 %. The final curing could be optimalize by postcuring at elevated temperatures.
